CONDITIONS OF PLAY

- **4 bowl pairs.** (2-2-2-2)
- Players to attend wet or fine
- **Each game:** 15 ends **with a time limit of 2.5 hours each game** (not including any trial ends)
- **Two trial ends prior to start of first & second games.**
- No dead ends - Jack to be re-spotted on the 2-metre mark.
- No restriction on "movement of players".
- Either player can play Skip. Playing positions may be changed at the completion of any game.
- Scorecards will be provided by the District and must be completed by Skip **in ink.**
- Conducted under Laws of Bowls Crystal Mark 3rd edition v3.1 and WBNSW Cond of Play 2021.
- Players may wear any clothing bearing the BA logo (including club uniform). The attire of players in the team does not have to be identical.

SECTIONAL PLAY: ROUND ROBIN

Section winners will be determined, in the following order, by:

- **Game points** (3 points for a win; 1.5 points for a draw)
- If points are equal, **net shots** (total shots "for", minus points "against" ("**margin**")
- If still equal, number of **ends won**
- If still equal, by the **formula described in Law 27.2**

POST-SECTIONAL KNOCK-OUT ROUNDS

- The 7 Section Winners will play at St Ives BC on **Sunday 24 January**. (Schedule of play for the day to be advised in the first week of January.)
- District Champions will play the Manly-Warringah District Champions on **Sunday 31 January** to find the Region 15 winners.
- Regional winners proceed to the State play-offs at South Tamworth, 23-31 August 2021 (actual date for the Mixed Pairs t.b.a. by Women's Bowls NSW later in the year).
